### 3. Previous Minutes

The minutes of the previous meeting were signed as a true record.

**4. i.** Double Yellow Lines at Bredwardine Bridge - Ray Wallace has advised that a request to extend the lines to the Red Lion has been discussed, and has been ranked alongside the other 69 requests they have received relating to highway issues. Provisionally it has been allocated a start date of May 2012, but this may alter as new requests are received. It was noted that Amey are still awaiting official confirmation that the Cabinet Member is happy with the list of priorities. The present lines need retracing and Joe Neal accepted that they do not follow the contour of the road on the Bredwardine side of the bridge and that vehicles are able to park between the lines and the hedge. This issue will be added to the defect form.

# ii. Grass verge on either side of the approach road to Bredwardine Church -

The approach road is owned by Herefordshire Council, Andy Byng, adoption officer, will be contacted to ascertain ownership of the grass verges either side.

#### 5. Roads

Joe Neal and Rachel Davies gave an update on how the new Amey contract would deliver a better road infrastructure over the next few years.

Herefordshire rural is divided into three areas. The Golden Valley is in area three. Joe is the manger for our area. The main focus for 2010 is resolving drainage issues that are damaging the road infrastructure. A copy of the programme of works was made available.

The issue over who is responsible for clearing out ditches was discussed and further contact will be made to establish responsibility.

Although not in our area, the pot hole outside Bridge Cottage on the Lulham road will be reported and all other defects added to the form:-

Moccas – pot holes outside Castle Cottage and Rollsford.

Bredwardine – road breaking up on the corner between the bridge and the Church junction.

Preston-on-Wye -the lengthsman will be asked to clear the ditch on the corner opposite the Mill.

#### **6.** Correspondence

**Lengthsman's Scheme –** allocation of £3249 for the coming year – remains the same as last year ie. £90 per km

**Parish Plan** – Chris Gooding has asked for an update on the position of Wyeside Group completing a plan. Funding would have to be applied for again as new budgets commence. It was agreed that too much time has been spent discussing the project and to review a plan in a year's time.
