## 4. Parish Councillor Vacancy

Diane Bowen has resigned as Councillor for Bredwardine. A letter has been sent thanking her for her invaluable service over the last ten years. The vacancy will be advertised on the notice board, the Link and under the parish news in the Hereford Times.

### 5. Road Safety in Blakemere

A road safety issue arose at the parish meeting relating to the lack of visibility of oncoming traffic on the corner at Blakmere House where the junction meets the road to Preston. It was agreed to contact Mr Rogers and request that the hedge be cut back to the railings and the top taken down level with the height of the existing wall.

#### 6. Donation to Bredwardine Website

Following a request made at the parish meeting it was agreed to make a one off donation of £20 towards the cost of the website licence. At present local businesses and parishioners support it.

## 7. Roads

Following the parish walkabout, Amey have sent out a mini digger to clean ditches between Preston and Moccas although they have not targeted the locations previously reported. There are concerns with the increase of traffic on the narrow roads through the area during this time of year and the topic will be added to next month's agenda.
