# Minutes of the Meeting of Wyeside Group Parish Council held in The Village Hall, Preston on Wye, on Wednesday 6<sup>th</sup> March 2019 at 7.30pm

## In attendance

Cllr Dale (in the Chair) welcomed everyone to the Meeting.

## Public Question Time - Open Session with members of the public

An extended 30 minute period from 7.30 p.m. was allocated to hear any representations from the public concerning:

There were representations heard from the public concerning the application 190416. These concerned a number of issues which can be summarised as follows (not exhaustive)

- Negotiations concerning the proposal for the relocation of a public footpath to the west side of the application site should the planning go ahead
- Capacity of sewerage systems and possibility regarding easements as some pipe works may be located beneath the property of other residents
- Traffic issues of narrow lanes, bottle necks and concerns regarding lack of passing places and access. Risk of collisions.
- Standing water and drainage issues increased risk of this
- Issue of overlooking and privacy for existing properties
- Loss of lay-by amenity outside existing properties and narrowness of roadway
- Size of development and future growth "small scale" in policy from Neighbourhood Plan
- Concerns about capacity of infrastructure and amenities (school, shop, roadways)

There was a commitment made by the Parish Council to send comments and objections to the Planning Department and to include the proposal for the rerouting of the public right of way and any references to applicable policies from the Neighbourhood Development Plan. ## 6.1) To report on highway issues

Potholes had been repaired going through Moccas. There was an issue reported concerning a culvert at Woodbury Lane, half way down where the cottages are, due to the brickwork having been squeezed over into the ditch.

## 7. Footpaths and Tree Warden - To report on footpaths issues and trees

The Tree Warden and Footpath Officer, Cllr Newsome advised that he would be acquiring the Black Poplar Trees (4) for planting imminently. It was noted as being the rarest tree in the country. There was a gate on the ground at Pentre Lane requiring attention.

#### 9.3) Update from Jarvis Charity

Cllr Darbyshire advised regarding availability of funding for books and education where a bursary of up to £500 may be awarded subject to eligibility and funding. Care travel payments were being reviewed with the Charity looking the possibility of being able to help fund a "black spot" in funding. The Charity Almshouse provision was for 12 properties currently. No more almshouses were permitted to be constructed at present. The idea of a Library Vehicle was being explored.

Cllr Russell advised that the paper written by Dr Chu could be published in Link and Pump (contact details Cllrs Smith and Russell). The Parish Council were still awaiting feedback regarding possible locations to site defibrillators for Blakemere and Tyberton.
