Minutes of the Annual Statutory Meeting of Wyeside Group Parish Council held via Zoom Platform (during Covid 19 virus Lockdown) on Wednesday 6th May 2020 at 7.30pm

Cllr Rawstorne welcomed everyone to the Meeting. Thank you to Cheryl Russell for arranging the Zoom Meeting.

The Parish Council recorded a huge **VOTE OF THANKS** to all the volunteers who had kept those who were sheltering, and unable to go out for necessities, supplied with food and medicines during the lockdown period. Thank you all so much for caring and helping your fellow residents. Your help is very much valued and appreciated.

1. Open Session with any parishioners who have joined the Zoom Meeting

Matters raised were lack of availability for home deliveries for sheltering persons. Issues had been experienced with data base registration not picking up vulnerable people because of multi address entries and this was also a concern. There did need to be joined up NHS data for shielding information. The Ward Cllr would take up the issue with the Community Broker. A resident was happy to assist the Ward Cllr in finding out more and also including liaison with the National Cancer Research Institute.

There had been a testing for Virus Covid 19 arrangement set up in Merton Meadow car park in Hereford, for those booking a test, but this had disappeared and there was uncertainty around what had happened. The Ward Cllr would try to find out more information.

2. Election of Chair and receipt of acceptance of office

Cllr John Dale was proposed by Cllr O Whittall and seconded by Cllr Light. Cllr Rawstorne remained in the Chair for the Meeting. Cllr Dale accepted the role. Thanks were recorded to John for his previous and ongoing chairmanship.

3. Election of Vice Chair and receipt of acceptance of office

Cllr Simon Russell was proposed by Cllr Chu and seconded by Cllr Rawstorne. Cllr Simon Russell accepted the role.

4. Apologies for absence

There were apologies received from Cllr B Bowen. Cllrs W Whittall, J Hughes, D Roper and A Smith were not present on Zoom.
