# Minutes of the Parish Council Meeting of Wyeside Group Parish Council, held at the Preston on Wye Village Hall, on Tuesday 6<sup>th</sup> July 22 from 8.00 pm

## In attendance were:

Councillors: C. Chu (Chair), J Dale, J Green (from 8.20 pm) and R Mitchell plus Parish Clerk Mrs A. M. Wright, Lengthsman Paul Wright and one member of the public. PC Jeff Rouse was also present for the first part of the meeting.

Cllr Chu (Chair) welcomed everyone to the Meeting.

# 1. Open Session with any parishioners

PC Jeff Rouse was in attendance at the meeting. He advised that no crimes had been reported recently for the Wyeside Group of parishes. He explained about the keeping in touch e mail system via Neighbourhood Matters.

There were still a number of scams going on and also leaflet drops for traders who may not be what they appear. If there were any doubts, forward any leaflets to the police to check out whether they are genuine.

## 2. Apologies for absence and resignation of councillor

There were apologies received from Cllrs A Rawstorne, O Whittall, D Gurney and S Russell. Cllrs J Hughes, A Smith, H Light and D Roper were not present.

## 3. Declarations of Interest

There were no declarations of interest recorded.

## 4. To approve previous minutes of the Parish Council Meeting held on 7th June 2022

## 6. Roads/Lengthsman

## 6.1) To report on highway issues

The Clerk had reported issues with the drainage systems and seasonal flooding around the Moccas Deer Park, and the property known as Coach House, to Balfour Beatty following correspondence from a resident.

The Clerk and two councillors had attended a road marking and parking safety meeting with the Traffic Regulation Order Team, and also Staunton plus Brobury council members, on location at Bredwardine Bridge. Road marking proposals would follow, for consideration, once drawn up.

## 6.2) To look at work for the Lengthsman

Stile to be mended at Pentre Lane, plus any other seasonal requirements

## 6.3) To consider input for road safety meeting on 18/07/22.

The road safety tour was booked for the 18<sup>th</sup> July 2022. Ian Connolly from the West Mercia Police and Simon Hobbs from the Herefordshire Highways Department would go on tour to look at the roads, and speeding issues, with the Clerk and Chair plus possibly another council member. The grass triangle, at Blakemere Green, proposal in regard to possible tarmac overlay, had brought

forward quotes which were not viable for progression in regard to the parish council budget. The triangle situation would be taken back to the village meeting.

## 7. <u>Footpaths and Tree Warden – To report on footpaths and trees</u>

The footpath officer, Cllr John Green, had walked the paths and cut back overgrowth around some stiles etc. His observations indicated that some footpaths were being maintained and others required attention. He had cleared the steps at Blakemere, as discussed previously. There was a missing footpath sign at Lulham, this would be checked by the Lengthsman to see if it had been removed or just knocked down (Madley Parish).

The request for support from Blakemere for the Queen's Platinum Jubilee celebrations would be followed up by Cllr Chu. The Black Poplar tree, on the Blakemere Green, would be moved to a new location at the appropriate time and would be replaced by a Rowan tree. The fruit trees for the Jubilee commemoration in Preston on Wye would be followed up in the autumn. Cllr Chu advised that commemorative plaques were available for the trees, once planted.

The kiosk had been upgraded as a labour provided goodwill project and thanks were recorded to those who carried out the work.
